I am pleased to announce that, all issues of volume 7 were published online well within the time and the print issues were also brought out and dispatched within 30 days of publishing the issue online during the year of 2019. The Journal aims to flourish and to maintain the standards in research and practice, providing an [open access platform](#) and opportunity to present evidence-based research studies by Researchers/ Doctors/Medical Professionals/ Institutions.

Journal of Cardiovascular Diseases and Diagnosis during this year also brought out 5th World Heart Congress and 4th Global Summit on Heart Diseases, which consisted of ~ 50 abstracts. All published articles of this journal are included in the [indexing](#) and abstracting coverage of CAS Source Index (CASSI), Index Copernicus, Google Scholar, Sherpa Romeo, Open J Gate, Academic Keys, JournalTOCs, Electronic Journals Library, RefSeek, Hamdard University, EBSCO A-Z, OCLC- WorldCat, SWB online catalog, Virtual Library of Biology (vifabio), Publons, Geneva Foundation for Medical Education and Research.

During the calendar year 2019, journal received a total of 36 papers from authors all around the world, out of which 14 articles (38%) were

rejected in the preliminary screening due to plagiarism or being out of the format and peer review process. During 2019, in the 6 issues of Volume 7 around 22 articles were subjected for publication after they are accepted in the peer review process. A total of 130 research scientists from all over the world reviewed the 36 articles published in volume 7. Average publication lag time of an article was further reduced to 2-3 weeks.

Journal of Cardiovascular Diseases and Diagnosis also announces its new association with HILARIS group for Archiving, Journal maintenance, financial purpose and support. However, the journal will be running its original website parallel for Editorial and review work process to maintain its highest standard of scientific work. Association with HILARIS group has increased Readership Metrics of Journal of Cardiovascular Diseases and Diagnosis.
