Editorial

I am pleased to mention that during the year 2019, all issues of volume 8 were published online well within the time and the print issues were also brought out and dispatched within 30 days of publishing the issue online.

Journal of Trauma and Treatment during this year also brought out TRAUMA, EMERGENCY MEDICINE & CRITICAL CARE and TRAUMA, EMERGENCY MEDICINE & CRITICAL CARE 2020 conference proceedings, which consisted of ~ 50 abstracts.

All published articles of this journal are included in the indexing and abstracting coverage of Index Copernicus, Google Scholar, Global Impact Factor (GIF), CiteFactor, Electronic Journals Library, RefSeek, International committee of medical journals editors (ICMJE), Hamdard University, EBSCO A-Z, Virtual Library of Biology (vifabio), Studies receiving funding from a funding organization that is included on the list of PMC and Research Funder Policies or authors having NIH grant were submitted to PubMed (PubMed NLM ID: 101630970).

During the calendar year 2019, JTM received a total of 30 papers, out of which 6 articles were rejected in the preliminary screening due to plagiarism or being out of the format and peer review process. During 2019 around 26 articles were subjected for publication after they are accepted in the peer review process. In the 4 issues of Volume 8 published during the year 2019, a total of 26 articles were published (at an average of 5 articles per issue) of which, articles were published from authors all around the world. A total of 104 research scientists from all over the world reviewed the 30 articles published in volume 18. Average publication lag time of an article was further reduced to 2-3 weeks
