

"G-d's Physics" New 21st Century Paradigm: A Complete Integration of "Space" & "Energy", "Mass" & "Time"!

Abstract

Twenty-first Century Theoretical Physics is undergoing a "Paradigmatic-Shift" (akin to Einstein's Relativity Theory (RT) "Paradigmatic Shift" over 100 years ago) from the Old "Material-Causal" Paradigm underlying both RT and Quantum Mechanics (QM) to the New "Computational Unified Field Theory" (CUFT), recently called "G-d's Physics" New Paradigm! This New "G-d's Physics" Paradigmatic-Shift was called for due to the apparent "theoretical inconsistency" between the two "pillars" of the Old "Material-Causal" Paradigm, i.e., RT & QM, as well as the inability of the Old Paradigm to account for up to 95% of all the mass and energy concepts that could not be verified empirically; The New "G-d's Physics" Paradigm is based on the discovery of a singular, higher-ordered "Universal Computational Principle" (UCP) which simultaneously computes all exhaustive spatial pixels in the universe for each consecutive "Universal Frame/s" (UF) at the unfathomable rate of $c^2/h=1.36\cdot 50$ (sec), with the entire universe "dissolving" into the UCP's singularity "in-between" any two consecutive UF's frames! This New "G-d's Physics" A-Causal Computation Paradigm was shown to challenge, negate and revise some of the most fundamental assumptions of the Old "Material-Causal" Paradigm such as: the "Big-Bang" Model, Einstein's Equations, discarding of "dark-matter" and "dark-energy" as "superfluous" (non-existent!) and QM's "material-causal" assumption regarding the "collapse" of the probability wave function due to its assumed direct physical interaction with another subatomic "probe" element. A few key new "Theoretical Postulates" of the New "G-d's Physics" Paradigm include: the "Universal Computational Formula" shown capable of unifying the Four basic Forces, as well as the four basic physical features of "space", "energy", "mass" and "time", and integrate all key relativistic and quantum laws and relationships. Nevertheless, "G-d's Physics" New "A-Causal Computation" Paradigm points at the complete dependency of the UCP's simultaneous computation of all exhaustive spatial pixels in the universe upon the UCP's "Ten Laws of Hierarchical Manifestation" which include: its Three "Computational Dimensions", "Supra Spatial-Temporal Reservoir", "Dynamic-Equilibrium Moral Principle", "Expansion of Consciousness (Hypothesis)", Collective Human Consciousness Focus (Hypothesis), "Reversed-Time Goal Hypothesis", "Good-Will" & "Free-Will" characterizations of the UCP; Therefore, the New "G-d's Physics" Paradigm of 21st Century Physics portrays an entirely "New Universe" – which completely depends on the UCP's continuous computation- "dissolution" sustenance- and evolution- of all exhaustive spatial pixels comprising the universe towards the "Ultimate Goal" o a "Perfected: Physically, Morally and Spiritually" State of the World (and Humanity) which realizes the Singularity, "Unity" and "Goodness" of this "Universal Consciousness Reality", called: "Geula" in Jewish Tradition!

Introduction

Nevertheless, approximately one hundred years since Einstein begun his quest for such a "Unifying Field Theory" Theoretical Physics is increasingly seeking such a "Theory of Everything" which would essentially accomplish Einstein's vision of unifying RT & QM as well as all of the Forces of Nature; Indeed, Einstein's own "vision" was to unify space, time, energy and mass, RT & QM, and the plethora of elementary subatomic particles-within one singular formula, stemming from a higher-ordered theoretical understanding of the nature of the "Field"-which encompasses, integrates and transcends the narrow constraints of the current "Relativistic" and "Quantum" theoretical models... It is no "secret" that quite a few of Einstein's hypotheses and "predictions" were tested and validated empirically many years after his passing in

1955- which has led to multiple Nobel prizes, e.g., including his "visionary" hypothesis of "gravitational waves", "gravitational lensing" etc.! [1].

Amazingly, it seems that Einstein's major quest for a grand "Unifying Field Theory" is being fulfilled by what's considered today as Physics New 21st Century Paradigm, i.e., the "Computational Unified Field Theory" (CUFT), recently also termed: "G-d's Physics" Paradigm! Prior to describing the gist of this New "G-d's Physics" Paradigm (CUFT) and delineating its basic theoretical postulates, it is important to first, capsule the essence of the "Paradigmatic-Crisis" of 20th Century basic "Material-Causal Paradigm", e.g., underlying both RT & QM and its inevitable ensuing "Paradigmatic-Shift" to the New "G-d's Physics" (CUFT) Paradigm of 21st Century Theoretical Physics: Perhaps the clearest instance indicating the basic "Paradigmatic-Crisis" of 20th Century's Material-Causal Paradigm is the apparent theoretical inconsistency that seems to exist between RT's strict "Speed of Light" barrier for the transmission of any light signal across space and time – as opposed to QM's well known (and empirically validated) Quantum-Entanglement" phenomenon; according to RT's strict Light Speed Barrier it is not possible for any signal (or any physical effect) to travel- or affect- any other element at a speed greater than the Speed of Light; In contrast, the empirically validate "Quantum Entanglement" phenomenon indicates that a subatomic measurement of any one of Heisenberg's "Uncertainty Principle's" "complimentary pairs", e.g., "space" and "energy", or "time" and "mass"-in one of two "entangled particles" will "instantaneously" determine the other complimentary pair's measurement accuracy level (constraint) in the other "entangled particle" (e.g.,

separated by a greater distance than can be traversed by a light-signal), thereby clearly "violating" Relativity Theory's strict "light Speed Barrier"!? Additionally, as analyzed and defined by the great Philosopher of Science Thomas Kuhn (1962), the Old "Material-Causal" Paradigm underlying both RT & QM indicated the "clear signs" signifying a "Paradigmatic-Crisis"-as shown by its inability to explain a series of key empirical (or theoretical) phenomena, i.e., perhaps the most "glaring" one is its inability to explain the accelerated expansion of the physical universe, which is attributed to the purely hypothetical concepts of "dark-matter" or "dark-energy", which are assumed to comprise up to 95% of all of the "matter" and "energy" in the universe, but which yet cannot be empirically directly validated (despite numerous attempts to do so)! Moreover, the inability to unify or explain between the three basic "Strong", "Weak" and "Electromagnetic" Forces and the "Gravitational" Force of the Standard Model also indicate a basic "failure" of the Old "Material-Causal" Paradigm to adequately account for the plethora of physical phenomena (existing both in the relativistic and subatomic realms)-clearly calling for a fundamental "Paradigmatic-Shift" in 21st Century Theoretical Physics! Interestingly, once again, Einstein played a major role in demonstrating such a "Paradigmatic-Shift" from the Old "Newtonian Classical Mechanics" towards the (then "new") Relativity Theory and subsequently Quantum Mechanics Paradigm of 20th Century Physics-simply by discarding the "superfluous" (purely hypothetical) "ether" concept which also could not be detected empirically (despite numerous attempts) and postulating a few simple new "Theoretical Postulates"; [2].

Similarly, the New "G-d's Physics" Paradigm discarded the purely hypothetical concepts of "dark-matter" and "dark-energy" and introduced several new Theoretical Postulates including:

The "universal computational/consciousness principle"

According to the New "G-d's Physics" Paradigm, there exists a singular higher-ordered Universal Computational/Consciousness Principle (UCP) which simultaneously computes every exhaustive spatial pixel in the universe at the unfathomable rate of " c^2/h " = 1.36-50 sec(!) giving rise to an extremely rapid series of "Universal Frames" (UF's) comprising the entire physical universe at every such "minimal time-point", wherein "in-between" any two such consecutive UF's frames the entire physical universe "dissolves" back into the singularity of this UCP! This UCP possesses three "Computational Dimensions", e.g.,: "Framework" ("frame" vs. "object"), "Consistency" ("consistent" vs. "inconsistent") and "Locus" ("global" vs. "local")-two out of which "Framework" and "Consistency" produce the four basic physical features of "Framework"-consistent ("space") or "inconsistent" ("energy") and "Object"-consistent ("mass") or "inconsistent" ("time") physical features that continuously and simultaneously compute any exhaustive spatial pixel in the universe for each consecutive UF's frame/s! Another key new discovery made by the New "G-d's Physics" (CUFT) Paradigm is its insistence that this singular higher-ordered UCP simultaneously computes all of the exhaustive spatial pixels in the universe for each consecutive UF's frame/s at the incredible rate of " c^2/h " = 1.36-50 sec(!); and that "in-between" any two consecutive UF's frames the entire physical universe and all of its constituting exhaustive spatial pixels "dissolve" back into the singularity of this singular higher-ordered UCP!

"G-d's physics" new "a-causal computation" paradigm

The "computational invariance principle" & "universal consciousness reality"

Hence, the discovery of the New "G-d's Physics" Paradigm completely alters and revises our basic conception and understanding of the origin- nature- sustenance- dynamics- and evolution- of the entire physical universe, e.g., at both its macroscopic ("relativistic") and microscopic ("quantum") computational levels; At the macroscopic level, we realize that the physical universe could not have been "caused" or "created" by an initial "Big-Bang" nuclear event! This is because, according to RT's "Big-Bang" Model, the entire universe, e.g., including all of its suns, galaxies, mass, energy (space and time) have been "caused" or "created" by an initial nuclear explosion – which implies that such a "nuclear event" took place in the "first", "second", "third", etc. UF's frame/s – leading up to the creation of certain mass, energy, suns and subsequent galaxies etc. But since, as stated above (and previously), there cannot exist any such direct (or even indirect) physical interaction/s between any two (or more) exhaustive spatial pixels existing either in the same- or different- UF's frames (e.g., due to the UCP simultaneous computation of all exhaustive spatial pixels comprising every consecutive UF's frame/s and the complete "dissolution" of the entire physical universe "in-between" any two consecutive UF's frame/s), therefore the New "G-d's Physics" Paradigm negates the basic "material-causal" assumption of the Big-Bang Model-instead pointing at the continuous computation- "dissolution"- re-computation- and evolution- of every exhaustive spatial pixel in the universe by the singular higher-ordered UCP for each consecutive UF's frame/s! Instead, we reach the inevitable (surprising) theoretical conclusion, wherein what seems as the curvature of "Space-Time" by "massive objects" (and conversely the determination of those "massive/less-massive objects" as apparently "caused" by this "curved Space-Time") – truly only arises from the UCP singular higher-ordered simultaneous computation of all exhaustive spatial pixels in the universe (for each consecutive UF's frame/s), i.e., based on the discovery of the UCP's "Universal Computational Formula" (UCF) which completely integrates the four basic physical features of "space", "time", "energy" and "mass" for its simultaneous computation of all exhaustive spatial pixels comprising the entire physical universe! Hence, the New "G-d's Physics" Paradigm entirely revises our basic understanding of the origin- sustenance- and evolution- of the entire physical universe: not as created by an initial "random" Big-Bang nuclear event, nor as being governed by any "material-causal" physical interactions between certain "massive-objects" and "Space-Time" (which are assumed to "curve" Space-Time etc.), nor as being driven by purely hypothetical "dark-matter" and "dark-energy" entities (which are assumed to "cause" the accelerated expansion of the physical universe); Nor is the subatomic realm governed by direct (or indirect) physical interactions between subatomic "probe" and "target's probability wave function" which "causes" the "collapse" of the probability wave function into a singular complimentary (space-energy or time-mass) value?! Instead, the New "G-d's Physics" Paradigm forces Science to accept the basic fundamental discovery of a singular higher-ordered UCP which simultaneously computes all exhaustive spatial pixels in the universe for each consecutive UF's frame/s! Instead, we begin realizing that since there cannot exist any direct (or even indirect) physical interactions between any two (or more) exhaustive spatial pixels in the universe-existing either in the same- or different-UF's frames, and moreover that the entire physical universe "dissolves" in-between" any two consecutive UF's frames, therefore the whole existence, "dissolution", sustenance, and evolution of the entire physical universe cannot be explained through any direct (or even indirect) physical interactions between any two (or more) exhaustive spatial pixels, but may only be explained based on the UCP's singular higher-ordered (simultaneous) computation of all exhaustive spatial pixels in the universe for each consecutive UF's frame/s! any two consecutive UF's frame/s; therefore the "Computational Invariance Principle" postulates that only the singular (computationally-invariant) UCP may be considered as "constant" (and "real"), whereas the entire physical universe may only be seen as "computationally-variant"-that is, as existing only "phenomenally" and "transiently" "during" the UCP's computation of each consecutive UF's frame/s, but "dissolving" back into the singularity of the UCP "in-between" any two consecutive UF's frames! Even more profound is the associated "Universal Consciousness Reality" theoretical postulate which suggests that since only the "Universal Computational/Consciousness Principle" (UCP) is seen as "constant", "continuous" and "unchanging", whereas the "phenomenal", "transient" physical universe exists only as solely produced by this Universal Consciousness Principle (UCP); therefore, we reach the inevitable conclusion wherein there truly exists only one singular higher-ordered "Universal Consciousness Reality" (UCR)-which solely exists "in-between" any two consecutive UF's frames, and which manifests as the physical universe "during" each consecutive UF's frame/s!

As pointed out previously, it is essential to understand that unlike the Old "Material-Causal" Paradigm's "Materialistic-Reductionistic" basic approach which sought to "fragment" and "dissect" any physical phenomenon into more "rudimentary" material elements, e.g., assumed to "cause" or "Explain" the given physical phenomena, entity or "law", the New "G-d's Physics" Paradigm negates and transcends such "Materialistic-Reductionistic" approach since it recognizes the fact that no such "elementary" or "basic" "material" entity, particle, force/s or even "law" can exist "independently" of the singular higher-ordered UCP (or UCR) which solely (and continuously) exists both "during" its simultaneous computation of all exhaustive spatial particles comprising each consecutive UF's frame/s and also exists singularly (without the presence of any physical universe) "in-between" any two consecutive UF's frame/s; On the contrary, as we've seen already, the apparent "transient-phenomenal" existence of each of these "basic subatomic particle/s" or "basic (four) forces" etc. – can only be (truly) explained based on the singular higher-ordered UCP's (UCR's) computation of any exhaustive spatial pixel/s for each consecutive UF's frame/s! We therefore need to outline (once again) those "UCP's Hierarchical Laws of Manifestation" – which unlike the Old "Material-Causal" Paradigm's "Materialistic-Reductionistic" approach actually "ascend"- and become increasingly "comprehensive"- and unitary"- and depend upon each other as higher- and more inclusive- manifestations or characterizations of this singular higher-ordered UCP/UCR!
