The Role of President in Living Systems

But the essence of this article is the assertion that it goes about an activity what is proper to all (!) until now known systems and the older and developer are these systems the more important is this presidential activity.

In this meaning it is also necessary to refine the expression of president itself. It is used as a euphemism for a function staying over three pillar of a democratic society over the legislative, executive and judicial power.

Incorporation into the System

Let from personal reasons the author can label the presidential position, function or an appropriate part of control of the system as LAS. This function relates to the existence of every system. It not only defines this existence by its activity, but also monitors and evaluates it. By its uniqueness, it represents the uniqueness of the system and thus externally of the whole object.

A living system has many parts with many specialized activities [1]. However, these can be divided into two groups-the parts working with tension in the area of success of elements and the group for the area of satisfaction of elements and LAS belongs to this group. However, the remaining or generally some parts of the system are active, and the elements have the idea that everything is already in order. Until the LAS position, i.e. the integrating, triggering and externally overarching factors, enters into the system. Until then, there is no object! The existing organization was at a lower development stage.

After the first umbrella activity, the LAS is repeated for some time. However, it is not a delay in the time of the whole object, which is defined just by entering the "game" LAS, it is time at lower levels. And the time of the object starts to run faster, in other words it is defined more and more often. And the same goes for its existence.

Constitutional order

In human society, an organization that is one of the most primitive, because of the youngest, in the general system of mass organization, is the stimulating activity of the LAS in appointing the government or its ministers. So much in the direction out of the dark matter, that is, into a world where the tension between the elements arises from the uneven distribution of money and success. The LAS in all systems, even in some galactic organizations, has no influence on the further management activity. So, in the case of human society government. LAS remain in the field of dark matter; he only appoints it.

Both of these forming activities are the result of analytical activity of the LAS monitoring the existence of the system. In the case of a company, its eventual outcome is the announcement of elections, followed by the LAS's formative work.

It seems that in the imperfect (!) Human systems, that is to say in the little existing one. The LAS is only very carefully allocated its powers. Usually this is the result of the activities of other parts. With the advancement of the system and the organization of the system, this role of the LAS will undoubtedly be strengthened, independent. Due to the time of e.g. the elements of society, its activity will be more frequent-in favor of both. That is on the one hand, the object or the state, and on the other, the elements, i.e. the citizens.

Information stimuli for LAS

The author's knowledge to date is that dark matter is like a control structure composed of two parts. In addition to the LAS discussed, it is an analogy of a democratic parliament. Like LAS, it works with element satisfaction, but in a different way. In the process of its evaluation it creates axle programs. Here, too, it is a stress or irregularity, an unjustified distribution of satisfaction from the perspective of the elements. And it is this view that becomes the basis of future "party programs" and they are gradually transformed into laws. These then represent the invisible or poorly visible third part of DM that enters the LM and affects the system by shaping the frameworks of behavior in dealing with stress in the distribution of money.

The information stimulus for LAS is of a different kind. He does not follow the tensions of satisfaction throughout the object. That would probably not be a very effective way. As a result of model analyzes of stock markets, LAS observes satisfaction in the form of overall system satisfaction. This is based on the fact that this satisfaction manifests itself in migratory pressures. Whether immigration or emigration and ideally only on tendencies. That is, not in "completed" migration, but in tension at the system boundaries.

In the case of US stock markets, this is a tension between different parts of the real estate market. If in one part the satisfaction distribution is different than in the other, it is an alarming incentive for the LAS. Based on the maturity of the system, the LAS experience and its learning, the LAS trigger can be triggered, and the wheel rotated the existence of the object at the highest level.

Conclusion

Although many political scientists are denying the merits of the president's function in a democratic society or opposing his direct election by citizens, the study of the "wiser" systems shows that this function is not only justified, it is even necessary. And since these systems are wiser, it is likely that its role and seriousness will gradually increase. The gradual digitization will allow a completely different interference in the functioning of society by both the citizen and the LAS. But the greater the possibility, the more organized the system society. The more it exists, the more it will need the LAS, in this case the "president".
