Researchers can perform differential gene expression analysis to identify genes that are significantly unregulated or down regulated in specific cell populations or conditions. Integrative single-cell analysis can reveal regulatory relationships between genes and transcription factors, helping to understand the molecular mechanisms controlling cell behaviour. CSCs can also give rise to non-stem cancer cells, known as progenitor cells, which can further differentiate into various cell types within the tumor. This hierarchy of differentiation contributes to the complexity of the tumor. CSCs are thought to be the cells responsible for initiating the formation of a new tumor. They have the ability to self-renew and differentiate, allowing them to initiate tumor growth in a new location.
