An aerial snow cover index should offer a reliable estimate of continental-scale snow cover variations that is free from the issues discussed above if station data are uniformly distributed in space and time over the region covered by a continental snowline. When paired with the Canadian dataset, the most current daily snow depth dataset provides virtually comprehensive continental-scale coverage of snow depth over NA for the region south of 558N. As a result, it was possible to create a NA monthly snow cover index for the time period of November to April, when the snow line is south of 558 N.
